- Obavezna
- Jednosmjerno slijepa
- Nema nekih specifičnih uputa

# Recenzenti u CMJ

- Bar 2 recenzenta
- Statistička recenzija

# Rezultati recenzije

- Veliki broj recenzenata ne odgovara na poziv na recenziju
- Značajan broj recenzija nije koristan
- Iznimno teško je skupiti dovoljan broj kvalitetnih recenzija u razumno kratkom roku

- Opisan u popratnom pismu (cover letter).
- Odnosi se na preinake u radu.

# Kako nadopuniti sustav recenzije?

- Trijaža
  - Brza,
  - Efikasna
  - Bez jasne povratne informacije autorima
  - Oko 2/3 radova odbija se u postupku trijaže

# Zašto moramo nadopuniti sustav recenzije?

- Copyediting
- Jezično uređivanje
- Produkcijsko uređivanje
- Probni otisak

# Tko snosi konačnu odgovornost?

- Recenzenti?
- Glavni urednik?
- Autori?

# Klasični sustav recenzije ili alternative?

- CMJ ostaje u klasičnom sustavu – do daljnjega
- Neke alternative:
  - Bez recenzije
  - Post recenzije

# Quality of journal

- Only citations count – IF

# Quality of scientist

- Only citations count – h-index
